- ◆ **by requiring equipment to comply, with essential requirements!**

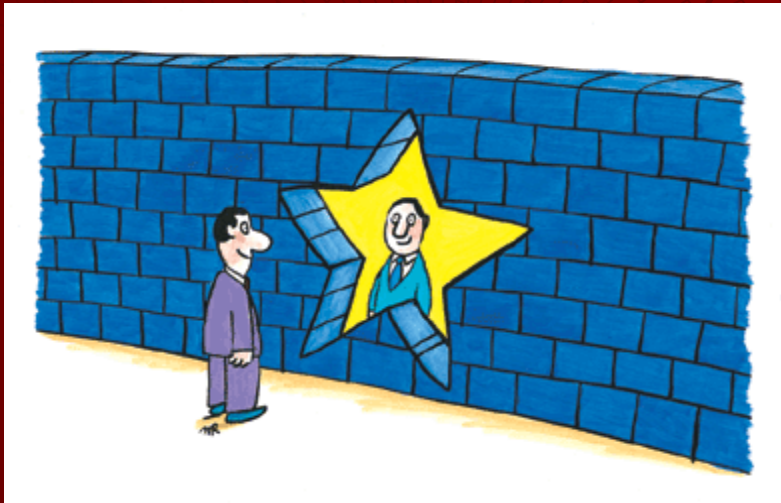

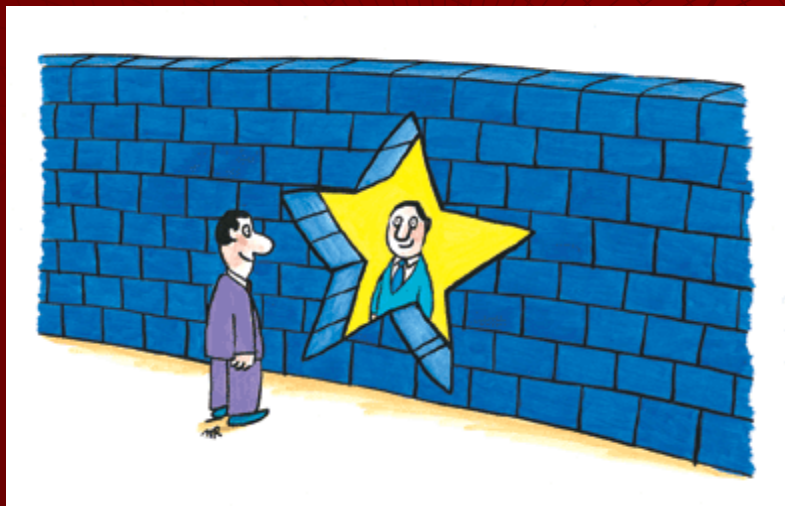
# What is the internal ("single") Market?

**Internal Market = an area without internal borders, guaranteeing the free movement of electrical and electronic equipment!**

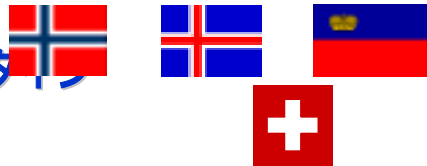

# How large is the Market for CE Marked products?

## CONSUMERS

- ◆ 25 EU countries = 460 million
  - ◆ EFTA countries = 12 million
  - ◆ EU from 2007  
(apply already CE marking) = 30 million
  - ◆ EU membership requested = 152 million  
(most apply already CE marking)
  - ◆ Non EU but applying CE  
(countries such as Egypt) = growing
- Total = 654 million**



# CEマークを付けた製品の市場は どれ位の規模か？

## 消費者数

- ◆ 25 EU加盟国 = 4.60億人
  - ◆ EFTA加盟国 = 1.200万人
  - ◆ 2007年以降のEU  
(CEマーキングを既に申請) = 3,000万人
  - ◆ EU加盟を申請  
(ほとんどが CEマーキングを申請) = 1億5,200万人
- 合計 = 6億5,400万人
- EUに加盟していないが CEを適用  
(エジプトなどの諸国) = 増加
